3.1 SCHOOL PERFORMANCE PLAN – Ms. Uy presented the School Performance Plan.

Mr. Babbitt and Mr. Roth asked about the Math goal and the concern of that the 3% increase may be too high of a goal to attain. The Math trend data showed that our math scores have stayed around 76%.

Mrs. Southards inquired about the MAPS scores this school year as compared to the past MAPS data from previous years.

3.2 SCHOOL DATA – Mrs. Hurst shared the survey and MAPS data. The Parent Survey data showed that parents believe we have enough resources and teachers are doing amazing. Needs include more small groups and more chat room time, etc.

Mrs. Hurst talked about the MAPS data and taking into account the virtual testing environment. Grades 3-5 were more accurate than our K-2 data. Multiple sources of assessments in the classroom help us have more accurate measures.

Mrs. Greer asked if the students will catch up or close those gaps. Mrs. Schibetta and Mrs. Alexander shared about how students are showing growth with the standards being currently taught. It may look different or may be a slower pace, but our students are learning.

Mr. Babbitt asked about MAPS and the 40th percentile. Mrs. Hurst explained the Read by Grade Three Legislation.

Mrs. Southards asked for insight on the percentage of students not logging onto distance learning. Has there been discussion in the District level about this? Mrs. Hurst shared the number of students she checks on daily.

Mrs. Alexander shared that we are lucky to have extra resources at our school. Her students are all logging in. GoGuardian helps keep students on track too.
